### Introduction

PwC is committed to protecting your privacy. This privacy statement explains our information collection practices with respect to NFT Generator and how we use, share, and protect that information. Note, this privacy statement applies solely to NFT Generator and does not apply to other PwC websites or other PwC offerings.

## **Information Collection**

When you access or otherwise use NFT Generator, we will collect information about you and how you interact with NFT Generator. We collect information about you through: information you provide.

# Information You Provide

When you access NFT Generator, you may choose to provide information about yourself such as: identifiers and contact information including your email address and personal digital wallet public key. By way of example, you may choose to provide your information in the following circumstances:

- To transfer the NFT watch collectable created during the NFT Generator experience to your personal Digital Wallet if you so choose
- Registration for or otherwise accessing NFT Generator
- Requesting support
- Contacting us for further information

PwC does not intend to collect sensitive personal information about you through the NFT Generator. Sensitive personal information includes a number of types of data, for example data relating to: race or ethnic origin; political opinions; religious or other similar beliefs; trade union membership; physical or mental health; sexual life or criminal record. Please do not submit sensitive personal information through the NFT Generator.

### **Information Use**

We use the information we collect as described above for various purposes depending on the context in which we collected such information. For example, it may be necessary for us to process your information in order to process a transaction or provide a service you have requested or otherwise in accordance with a contract between us, or we may process your information in accordance with your prior consent (where you have provided such consent).

We use the information we collect for the following business purposes:

- Initially registering you to NFT Generator;
- Totransfer the NFT watch collectable created during the NFT Generator experience to your personal Digital Wallet, if you so choose;
- To operate, maintain, customize, analyze and improve NFT Generator or similar products;

- To maintain and improve the safety and security of NFT Generator, and to run our internal operations;
- To prevent and enhance protection against fraud, spam, harassment, intellectual property infringement, crime, and security risks;
- To comply with law, rules, regulations, legal obligations, professional and industry standards, as well as respond to and complying with subpoena, search warrant or other legal process, including establishing, exercising, or defending our legal rights;
- To fulfill your orders/requests and respond to your inquiries;

# **Information Sharing**

We are part of a global network of firms. In common with other professional service providers, PwC may transfer or disclose the information it collects, including your information, to third party contractors, subcontractors, subsidiaries, and/or other PwC firms for the purposes for which you have submitted the information and for the administration of our system or NFT Generator and/or other internal, administrative purposes. We transfer your information to third party service providers of identity management, website hosting and management, data analysis, data backup, security, and storage services.

NFT Generator uses a PwC owned Meta Oculus Quest Pro, a virtual, mixed, and augmented reality ("XR") hardware and software product that operates on a Meta platform under the Meta Quest brand, to facilitate the VR experience being demonstrated. The Oculus VR headset is not a PwC product and is utilized by PwC as an independent product to facilitate the NFT Generator. Please see the <u>Oculus Privacy Policy</u> for details on data collection and data handling practices related to Oculus.

PwC may disclose information to other third parties under the following circumstances:

- When explicitly requested by a visitor;
- As necessary to comply with law, rules, regulations, legal obligations, professional and industry standards, as well as respond to and complying with subpoena, search warrant or other legal process, including establishing, exercising, or defending our legal rights;
- As necessary in connection with a corporate reorganization, merger, sale, joint venture or other disposition of all or any portion of our business, assets or capital.

We do not sell personal information collected in connection with NFT Generator nor do we disseminate personal information collected in connection with NFT Generator to outside parties for consumer marketing purposes or host mailings on behalf of third parties.

# **Information Transfer**

Your information may be transferred outside of the U.S. or your country of residence. This includes to countries outside the European Economic Area ("EEA") and to countries that do not have laws that provide the same degree of protection for personal information. In accordance with applicable legal requirements, we take appropriate measures to facilitate adequate protection for any information so transferred.

Although not currently relied upon as an authorized mechanism for cross border transfers, PricewaterhouseCoopers LLP and its affiliated U.S. subsidiaries also adhere to the privacy principles in the EU - U.S. Privacy Shield Framework and the Swiss - U.S. Privacy Shield Framework as set forth by the U.S. Department of Commerce. ### **Information Retention**

We will retain the personal information collected by us through NFT Generator for as long as is necessary for the purpose(s) for which it was collected as set out in this privacy statement, provided that personal information may be held for longer periods where extended retention periods are required by law, regulation or professional standards, and in order to establish, exercise or defend our legal rights.

Further, you must provide us with sufficient information that allows us to reasonably verify you are the person about whom we collected personal information or an authorized representative. Please, however, refrain from sending us sensitive personal information.

Where permitted by law, you may use an authorized agent to submit a request on your behalf if you have provided the authorized agent signed permission to do so.

We may not be able to fulfill your request if we cannot verify your identity or authority to make the request and confirm the personal information relates to you. Making a verifiable request does not require you to create an account with us. We will only use personal information provided in a verifiable request to verify the requestor's identity or authority to make the request.

We will respond to your request within a reasonable timeframe in accordance with applicable law. We reserve the right to charge an appropriate fee for complying with a request where permitted by applicable law, and to deny a request where it may be manifestly unfounded, excessive, or unwarranted under applicable law.

We hope that you won't ever need to, but if you do want to complain about our use of personal information, please send us a message with the details of your complaint using our <u>general contact form</u>. Applicable laws may also give you the right to lodge a complaint with the data protection authority in your country.
